PHEP Budget report - Elaine LaCoursiere reported that all funds were spent down.

Review and vote to authorize cell phone and data plan payments. – Janice McCarthy noted that Brockton has had the benefit of having the cell phones for the previous year, but with no representation, she believes they should not get coverage for the upcoming year. If Whitman attends today they will be in compliance, otherwise they should not be funded. Brockton will lose funding this year for cell phones due to lack of attendance at meetings. DPH Update – Diane Brown Couture reported that Deliverables are out for B P3. She has a presentation and will lead a discussion on projects, as an abstract for the projects is due in September. Eric **Badger made a** motion to adjourn **at 1:45, with a** second by Arthur **Boyle with all in favor**.
